The South Texas Chapter of the Health Physics Society (STC-HPS) had its Affiliates Fair meeting on Saturday, January 29, 2005, at the Brooks Officers Club, located on Brooks City-Base in Southeast San Antonio.

About 75 attendees came out to hear the vendors tell about the new instruments and services they provide. Also, national HPS President-Elect Ruth McBurney spoke twice. The STC members present were treated to a full day of interesting talks, and, at the end of the day, there were drawings for several great door prizes, which is always entertainment in itself.

Canberra, Iso-Tex, and Owens Scientific started the morning with talks about their products and services. After a break of Danish rolls, muffins, and coffee, the crowd was refreshed and ready for more talks. Suntrac Services, Global Dosimetry, Thermo Electron, and Phoenix Scientific told us about their companies, services, and new instruments. For the lunchtime speaker, our own Ruth McBurney spoke about the future of HPS. ## Minutes of the Executive Council Meeting of the South Texas Chapter of the Health Physics Society, Inc.

Brooks City-Base, San Antonio, Texas, Earth Tech Inc. Offices

**Persons in Attendance:** Executive Council (EC): John Salsman, President; Ken Krieger, President-Elect; Roy Craft, Secretary; Pete Myers, Treasurer; Stan Bravenec, EC Member; Stacy Krieger, EC Member. Committee Chairpersons in Attendance: David Fogle, Nominations Committee; John Hageman, Editor of *The Billet*; Linda Morris, Student Assistance; Karen Myers, Public Relations Committee; Susan Jablonski, Admissions Committee; Jim Sharp, Affiliates Committee; Bob Wilson, Legislative Affairs. Chapter Members and Guests in Attendance: Al Evans, Alisha Stallard, and Alta Craft.

**Call to Order**—John Salsman. With a quorum established, President Salsman called the meeting of the EC of the South Texas Chapter of the Health Physics Society, Inc. (STC-HPS), to order at 6:05 p.m.

**Approval of the Agenda**—A motion was made by Ken Krieger to accept the agenda. Stan Bravenec seconded the motion. With no further discussion, President Salsman called for a vote on the motion, and the motion passed unanimously.

**Approval of Minutes of EC Meeting on September 18, 2004**—A motion to accept the minutes of the meeting held September 18, as published in *The Billet*, was made by Ken Krieger, and Stan Bravenec seconded the motion. John Hageman stipulated that the version printed in *The Billet* is the official copy of the minutes. There being no further discussion, President Salsman called for a vote on the motion, and the motion passed unanimously.

**President's Report**—John Salsman. John S discussed the proposal to host the 2009 HPS Midyear meeting in San Antonio. He has continued to work with Lori Strong who contacted Marriott Riverwalk and found that they will have enough rooms available for the anticipated attendance at the meeting. The current dates proposed are January 11–14, 2009, with the option of January 18–21, or possibly January 25–28. John S expressed concern about the river being drained during some of these time periods, and Lori said that she will check. The current room rate quoted is \$160, which everyone agrees is excessive. The rates rise in February. She is going to contact Marriott again and the Hyatt about rates and other potential dates. The fees to use the Convention Center will be ~\$8600. John Hageman said the Convention Center called and is trying to negotiate better hotel rates and that they are also contacting the Hyatt about their availability and rates.

John S reported that he wrote thank you letters to Mr. Ratliff, Dr. Klein, Mr. Bays, and Ms. Glass for their participation in the

September 2004 Regulatory Conference; copies were provided to Roy Craft.

John S received an e-mail request from the Secretariat to provide a Mid-year Chapter update to Ray Guilmette. John S compiled and sent it to Ray; he also provided a copy to Roy Craft.

Update to the 2005–2006 HPS Meetings—Midyear Symposia – New Orleans – February 13–16, 2005. The Annual Meeting – Spokane, WA – July 10–14, 2005. The Midyear Symposia – Scottsdale, AZ – January 22–25, 2006. HPS Annual Meeting – Providence, RI – June 25–29, 2006.

The 2006 HPS Mid-Year Meeting will conflict with the normal time for the STC annual Affiliates Fair meeting. There was a discussion about changing the Affiliates meeting to September, when we plan a NORM and Industrial Radiation Safety meeting in Galveston. Jim Sharp will canvass the Affiliates to see if they are agreeable to a change in venue and date. We will still have four meetings next year.

The Chapter officers indicated they will continue supporting President-Elect Ruth McBurney as she fulfills her term of offices.

John S announced that Alisha Stallard and Dan Menchaca wish to serve on a local committee.

Status of Science Teacher Workshops—scheduled sometime in February 2005. No further information at this time.

### Action Items from September 17, 2004, Meeting

- ♦ Feasibility and acceptance of electronic dues payment and online access to the membership rolls. The EC agreed that electronic dues payment and access to the membership is both feasible and desirable. Comments centered on the cost and security of a system. The type of security and access control should be available at a reasonable cost to the chapter. One type of access control is to provide all members with a single password. Another method, more costly and labor intensive, is for each member to have a specific password and identity. The second method is probably prohibitive in cost and the support required. The payment of dues online

is separate from the availability of an online membership roll, which must be coordinated with the webmaster. It was emphasized that in addition to dues being collected, it is also requested to accept scholarship and STW donations via online payments as well. Pete and John H and John S will continue investigating costs of options.

- ◆ Establishment of a permanent scholarship in name of STC member. There was discussion by John S with Dr. Poston that a scholarship in the name of Dr. Neff would be appropriate. The EC recommended there be a scholarship for undergraduate students and one for Graduate students and that the current scholarship at TSTC be continued as it is now administrated. A general consensus at the EC meeting was that both Drs. Richard Neff and John Poston be honored by a scholarship administered by the STC that will only be awarded to attendees of institutions that support the STC-HPS. The scholarships will include Health Physics or equivalent, Medical Physics, and M.S. Public Health (emphasis must be radiation related). It was suggested that the STC-HPS begin the fund with \$50,000 and seek donations to develop a capital fund to service the scholarship from the income. A suggestion was made by a member of the EC that the graduate and undergraduate award recipients make a presentation at a subsequent STC-HPS meeting. John S and Pete will continue the process of the evaluation. Other members of the council will investigate corporate or private sponsorship.
- ◆ Membership Needs Assessment Survey—The STC plans to use the web site for the survey with an email notification to click on survey. The secretary will send the email, and John Hageman will report on the results. There will be one survey for members and a later survey for potential members. We can get names of RSOs/licenseses from TDH.

**Treasurer's Report**—Pete Myers. Pete reported an Operating Funds balance of \$38,148.15, Scholarship Funds of \$59,804.71, a Science Teachers Workshop Account of \$21,130.18, and a petty cash fund of \$150 bringing the total assets to \$119,233.04 as of December 31, 2004.

Pete asked the EC, especially former Treasurers, if the hand-out he presented was adequate to fulfill the requirements of the corporation charter. He noted that he looked into the accrual of funds to see if we had exceeded the constraints of our incorporation charter. He found that we did not have to submit supplemental tax forms to be in compliance with our limitation as a 501(c) 3 corporation since our receipts did not exceed \$25,000. Pete feels that our Operating fund is too large, and it should be transferred to savings. He stated that some income is still outstanding, and some trickling in will eventually increase ~\$1,800.

The Bank One merger with Chase is causing some bank changes. Chris Maxwell's reimbursement (~\$651 for bulk mailing of flyers for the Legislative Meeting) has not yet been made. No vote on that type of expense required. The direct expenses of

meetings need not be voted on by the EC, because they go against the profit margin for the conference.

Pete bought new suitcases for Treasurer records, since the old ones disintegrated at the last meeting. Eva Legler is waiting for reimbursement for Science Teacher Workshop (STW) expenses. As with meeting expenses, expenses for authorized STW activity do not need further EC approval. The EC approved the use of credit cards by officers to cover expenses of the chapter, especially the Science Fair meeting and Science Fair expenses.

Requests for reimbursement of expenses including those for Ms. Teachout to move the STC-HPS web site and other specific bills were submitted for authorization to be paid by the Treasurer. The motion to approve was made by Ken Krieger, seconded by Stan Bravenec, and passed by the EC unanimously.

**Secretary's Report**—Roy Craft. In sending out email for the society membership, Roy still has a problem of getting all of the messages sent to all of the members. There appears to be two problems. One is getting accurate email addresses for all of the members in his address book. The other is that some messages may be rejected as spam. Roy submitted his corrected email address to *The Billet* and the web site. The correct address is [rcraft@nctv.com](mailto:rcraft@nctv.com).

Roy is also continuing to develop information on the performance requirements and hints for chapter officers and committee chairs to pass on to those succeeding them. At the suggestion of John S, Roy will ask each officer to email a short description of their duties, along with hints on how to keep the Chapter functioning efficiently. He will combine the expectations, requirements, and suggestions into appropriate files for storage on different computer media and the web site.

### Standing Committee Reports

**Program**—Ken Krieger. Ken reported that we will have approximately 75 attendees and 10 Affiliates for the Jan. 29, 2005, meeting. The meeting will be in the Officers Club at Brooks City-Base, and we have the building for our exclusive use. There is a meeting room and exhibit area for the Affiliates, and the breaks will be in the exhibit area.

The next meeting is scheduled for April 16 in Waco at TSTC. The hotel accommodations will be the Country Inn and Suites. Lunch will be BBQ from Tom's Smokehouse, which is a local favorite. The speaker will be announced later. Ken was asked to write a letter to Drs. Poston and Hamilton with a copy to Dr. Burchill concerning the Student Paper competition being held at Waco.

A future meeting, the traditional Breakfast Meeting, will be at the 50th National Meeting in Spokane. The September meeting is planned for Galveston, and the topics will be NORM, Industrial Radiation Safety, and Source Control. At this time, we are canvassing the Affiliates to determine if that meeting could be the Annual Affiliates Fair meeting. The conflict with the mid-year meeting is the main reason to change the date of the affiliates meeting; but the potential for new attendees from the Oil and

other industries make this seem a reasonable tradeoff. Just prior to this meeting, the NRC has a scheduled meeting about NORM with David Fogle representing the Texas Health Departments. It is reasonable that he could provide an update of the NRC efforts at our meeting. Other speakers are also being considered.

John S asked the Secretary to invite the North Texas Chapter to the April and September meetings.

Susan reported that the qualified membership list for voting this spring would be limited to those who have paid their dues by March 1. She also restated that online membership addresses need to be available in a secure format so the members can use the lists but no one can access the roll for mass mailings. John Hageman said that the Webmaster, Jean Fox, of SwRI, might be able to implement a simple and cost-effective system for access control.

**Nominations**—David Fogle. David reported that his call for nominations for HPS national offices has not resulted in any nominations being received. Nominations for national awards recognition may still be submitted to David before February 19, 2005. The Chapter nominations for offices and awards have been very successful in the past few years.

We still need nominations for STC-HPS officers for the coming elections this spring. Stacy Krieger has been nominated for Treasurer-Elect, but we still need another candidate. We also need two candidates for Board Members, two for President-Elect.

The EC voted unanimously to support the Louisiana Chapter in their efforts to obtain the Founder's Award for Max Scott. A motion was made by Roy Craft and seconded by Pete Myers. David Fogle is to write a letter of support for the nomination of Dr. Scott, for John S to sign.

Jean Fox, of SwRI, is to be awarded Chapter Outstanding Service Award recipient for her work on *The Billet* and the web site.

**Public Relations**—Karen Myers. Karen reported that one article was submitted and published in the National Newsletter—“STC/DSHS Regulatory Conference well attended” was written by President-Elect Ken Krieger. The article will appear in the

February 2005 issue. Two photos were included in the article. One, courtesy of Jim Sharp, pictured HPS President-Elect Ruth McBurney and Cindy Cardwell, DSHS. The second, courtesy of Marilyn Kelso, DSHS, was a picture of the audience attending the meeting.

Other planned activities include continuation of submitting articles for the National HPS Newsletter about STC-HPS activities, continuing submitting articles to *The Billet*, and continuing the Longest-Standing, Continuously Active member series.

#### Appointed Committee Reports

**Science Teacher Workshop**—Eva Legler. No report

**Affiliate Membership**—Jim Sharp. Jim reported 10 Affiliates were present at the meeting with several presenting talks about new products and services. Jim will canvass the Affiliates to determine the feasibility of changing the timing of the annual Affiliates meeting from next January in San Antonio to the September meeting in Galveston.

**Legislation**—Bob Wilson. Bob reported that on December 27, 2004, the *Federal Register* carried a notice that several participating agencies, including the Department of Defense, the Department of Energy, EPA, NRC, the Department of Commerce, the National Institute of Standards and Technology, the Department of Interior, USGS, the Department of Health and Human Services, and the FDA announced the availability of the *Multi-Agency Radiological Laboratory Analytical Protocols Manual*. There is a new acronym to learn, MARLAP. The manual provides guidance for the planning, implementation, and assessment phases of projects that require laboratory analyses of radionuclides. The Register page reference is 69 FedReg 77228.

In a copyrighted story appearing on January 4, 2005, in the *Quorum Report*, a subscription journal, Harvey Kronberg, the Report's publisher, wrote that Sen. Robert Duncan would like to have the Texas Legislature weigh in on the proposal by WCS to amend its license to take up to 153.6 million pounds of 11e(2) byproduct material from Fernald, Ohio, at the company's Andrews County site.

On December 29, 2004, the Texas Department of Health Services sent a notice about the availability of draft changes to Section 289.230 of the Rules. This section is about Certification of Mammography Systems and Accreditation of Mammography Facilities. The changes can be viewed at [www.tdh.state.tx.us/radiation/draft.htm](http://www.tdh.state.tx.us/radiation/draft.htm). Although the deadline for submitting written comments is January 14, the agency could still consider comments made after the closing date.

On January 12, 2005, the NRC published its Final Rule amending regulations governing the use of byproduct material in specifically licensed portable gauges. The final rule requires a portable gauge licensee to use a minimum of two physical controls that form tangible barriers to secure portable gauges from unauthorized removal whenever the portable gauges are not under the control and constant surveillance of the licensee. The effective date of the rule is July 11, 2005. The citation for the rule is 70 Federal Register 2001. Bob distributed copies of the report to those interested.

TCEQ has proposed a rule that would allow a public water system to dispose of naturally occurring radioactive material waste into commercial Class I wells. The Commission will hold a public hearing on the proposal in Austin on February 24, 2005, at 2:00 p.m. Additionally, written comments may be submitted through 5 p.m. on February 28, 2005. Further information about the proposal can be obtained by contacting Debi Dyer at TCEQ at 512-239-3972.

**Publications**—John Hageman. John H reported on the upcoming deadlines for *The Billet*. February 11 is the deadline for the next issue. The Chapter meeting will be in Waco with the Student Papers contest. The meeting after that is the Annual Breakfast Meeting at the National Meeting in July.

**Student Assistance Committee**—Linda Morris. Linda requested support for Science Fair participation in 2005. *Education Grants for Fall 2005.* The applications are online. We have had one undergrad applicant so far. The scholarships for graduate and undergraduate students was also discussed in the Presidents report, with support for the TSTC being unchanged.

Stan reported that he received an email from our state point of contact (POC) stating he would address our training issues the first week of February, (he is out of town last week of January). The new POC has evidently been active. He ordered equipment for various Texas cities. Stan will make a concentrated effort for the month of February 2005 and see if progress can be made.

**Ad Hoc Strategic Planning Committee**—No report.

**Ad Hoc Fellowship Feasibility Committee Report**—Pete Myers. Pete gave an update (included in President's report section) on the group's progress for determining the feasibility of establishing a fellowship in John Poston's name. The EC decided to pursue the establishment of the fellowship rather than through the National HPS.

**Old Business**—During the President's report, we discussed the named Scholarships.

**New Business**—Pete discussed CEUs with the TDH concerning permission for the Chapter to give approval for credits rather than await their response to submittals. The state approves MRT credits, and we can approve LMT credits. Some professional medical societies are permitted to assign the number of CEUs through a vetting process. Pete is addressing the constraints of the approval process, to permit us to have the same approval process. Pete will send information to the President and the Secretary.

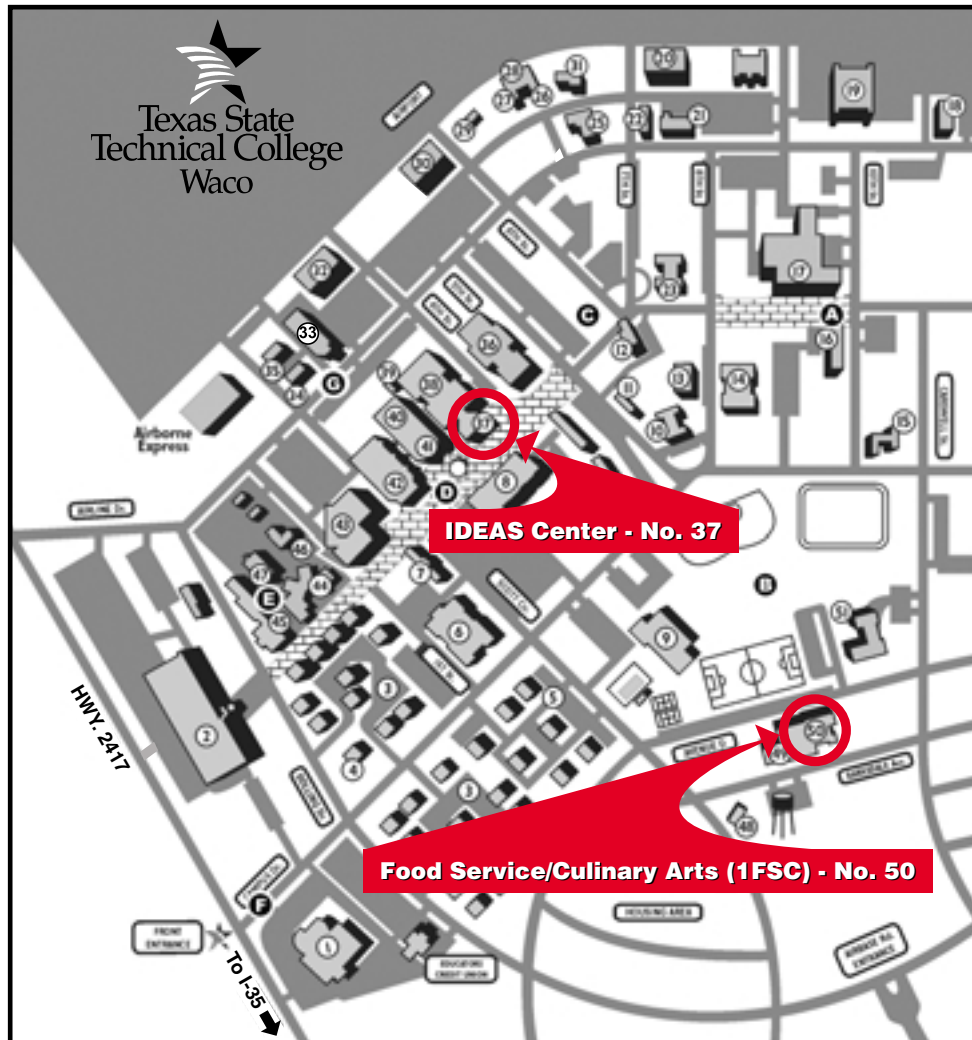
