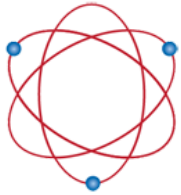

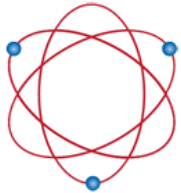

50th Anniversary Resolution

Fifty years ago, an agreement between the State of Texas and the U.S. Atomic Energy Commission became effective. On January 10, 1963, (then) Governor Price Daniel entered into an agreement with the Atomic Energy Commission for Texas to assume regulatory responsibility for certain radioactive materials in the state under Section 274 of the Atomic Energy Act of 1954, as amended (Agreement). This act made Texas the fifth State to become an “Agreement State” effective March 1, 1963. Under the Agreement, Texas assumed all licensing and regulatory authority over radioactive materials in the state, with the exception of special nuclear material in excess of a critical mass and radioactive material utilized by federal agencies.

Texas is one of only three Agreement States that has regulatory authority over uranium recovery and low-level radioactive waste disposal in addition to the authority exercised under the basic Agreement. The Texas Department of State Health Services regulates the safe operations of over 1,700 radioactive material licensees and over 20,000 x-ray, laser facilities, and mammography facilities. Through the Department of State Health Services, Texas was the first state to enact laser regulations; and the Department is the lead agency for emergency response planning and response to nuclear accidents. Also, the Department of State Health Services cooperates closely with the Texas Commission on Environmental Quality to safely regulate uranium mining, disposal of Low-Level Radioactive Waste, and non-oil and gas Naturally Occurring Radioactive Waste.

Therefore, be it resolved that the Texas Radiation Advisory Board hereby commemorates the 50th anniversary of the Agreement between Texas and the U.S. Nuclear Regulatory Commission, the successor to the Atomic Energy Commission, and that it honor all the individuals responsible for implementation and continuation of this historic compact.

This resolution was unanimously approved by the Texas Radiation Advisory Board at their February 8, 2013 meeting.

Bill (Hugh William) Bryant of Austin, Texas, passed away November 9, 2012

Bill (Hugh William) was born in Cosby, Tennessee on April 4, 1931. He married his wife, Alice Redmond, on June 18, 1954. Bill served his country as a veteran of the Korean War in the United States Air Force. He worked at Convair/General Dynamics in Fort Worth, Texas, for 19 years in the Nuclear Aircraft and Space Propulsion Division. He gave a fascinating presentation of some of his work on the nuclear powered jet at a recent STC-HPS meeting. Some of the radiation detection instruments Bill calibrated for NASA were left on the moon as part of the Apollo Program.

He was later employed for over 19 years at The University of Texas at Austin, where he retired as the Director of Environmental Safety and Health. He was a charter member and an Emeritus and Fellow Member of the Health Physics Society. Bill was an avid golfer and enjoyed serving his church and community as a basketball and softball coach, Sunday School Teacher, superintendent, and deacon-most recently at Great Hills Baptist Church in Austin, Texas.

In Bill's words, "God has been good to me, gave me a great family and has provided every need." Bill is survived by his daughters and their spouses, Betty and Russell Barrett, Rhonda and Ken O'Brien, and Donna and Rodney Lowry.

Remembering Clifford "Cliff" Elmont Winters, Jr.

In memoriam of Clifford "Cliff" Elmont Winters, Jr., 80, who passed away on Sunday, December 16, 2012, in Wichita Falls, Texas. He was born February 16, 1932 in New London, Connecticut. He is survived by Beverly Joan Porter, his wife of "59 years, 2 months, 7 days," stated in the manner that he would recite to her daily; his oldest daughter Lori Ann Strader of Wichita Falls; his son, Scott Joseph Winters of Knoxville, Tennessee; their respective spouses and family, totaling four grandchildren and one great-granddaughter; and preceded in death by his daughter Pamela Dru Rogers.

Cliff served in the U.S. Air Force during the Korean War and received instruction in the Navy's nuclear training program. After he left the military, Cliff supported the radiological testing program of nuclear submarines being built in Groton, Connecticut from 1955 to 1967. He was proud to have been a part of the team that made the USS Nautilus a reality. He was recruited by Todd Shipyards in Galveston, Texas, as the Radiation Safety Officer from 1968 to 1980. He supported the re-fueling operations of the NSS Savannah and was instrumental in commercializing the Technical Research Division. Cliff was the founder of Suntrac Services, Inc., and its President and CEO from 1981 to 1998. Those who knew him will remember Cliff for his dedication to family and friends.

Cliff was active in the Health Physics Society, especially the South Texas Chapter (STC); he recognized the value of having local chapters and actively engaged at every opportunity to support the Chapter's Affiliate Program. Cliff was given the honor of being named an Honorary Life Time Member of the STC-HPS for his serves as President, founder and Chairman of the Affiliates Program. The Affiliates of the STC are the principal source of income for the STC's funding of numerous student scholarships and speaker awards for several years. All current, past and student members of the STC are extremely thankful for all that Cliff Winters did for our Chapter.


Thank You, from Vickie Hurst

President's Report	Special thanks to Scott Nicholson for filling in during the president's maternity leave. HPS Nominations – a. Nomination email for Ken Krieger to be HPS Board Member was submitted August 2012 b. Bob Cherry plans to solicit a STC-HPS nomination for HPS president elect for fall 2013 election, which is due February 2013. The Billet Publication Online and New Format – a. The President gave recognition for SwRI's many years of support for The Billet. There will be trial run support of three issues of The Billet per year online at \$2,250 per year, donated by SwRI b. Please submit articles for the next edition of The Billet Potential September Topical Meeting – Radiation Sources and Radiography in the Oil & Gas Industry – a. Possible joint sponsorship by UTHSC-H, SPH, and SWCOEH CE b. Proposal to host at UTHSC-H in Houston c. Consider including non-HPS member oil and gas experts d. Interactive sessions relating Rig Counts and Overexposures in Texas and other states e. Topic is being discussed at the next Texas Radiation Advisory Board meeting Janet has a copy of a graph relating rig count to overexposure that can be emailed out. After much discussion this idea was approved. 2014 will be the earliest that another Regulatory Conference could be held if necessary.	
President-Elect Report	The July 24, 2012 STC-HPS Breakfast meeting had 24 attendees and it was the first "plated" breakfast (vs. buffet style). We had a financial loss of \$188. September 15, 2012 Annual topical meeting on Non-ionizing radiation – There were 68 attendees, 12 speakers and the National HPS President-Elect visit. We had a financial loss of \$488, which is partially due to incurring costs of supporting the President-Elect's visit. January 12, 2013 affiliates fair meeting – All affiliates were invited by both email and phone call and we had 9 affiliate speakers, 12 exhibits and 5 technical talks. The anticipated financial loss is expected to be between \$800 and \$2,000. Thanks to Jennifer Cerecero for initiating the planning. Annual and Student Meeting – April 20, 2013 will be held at the confirmed location of the TSTC Idea	

Center in Waco. Emails have been sent to professors soliciting student papers. Ken Krieger is setting up the room block at the anticipated hotel, Holiday Inn. It was decided that there should be 15 rooms in the room block and the price will be ~ \$99.

Suggested Speaker Policy –

- Annual topical meeting – suggest waiving registration and lunch fees for non-STC-HPS member speakers. For members, give option to waive or not (i.e. donating).
- Affiliates fair – suggest one waived reservation fee per attending affiliate, additional affiliate’s attendees will need to pay and give them an opportunity to sponsor breaks and lunch. Raising affiliate dues to \$200 and giving one free lunch was also discussed. An ad hoc committee will come up with a written policy regarding how we handle affiliate fees and will send around to vote. This should be done after we have a budget.
- Student meeting – Suggest no waivers as \$10 fee for students is quite reasonable.

Action Item:

Ad hoc committee to develop a written policy regarding Affiliate dues and send out for a vote.

Observations –

- Chapter Officers and Volunteers – please look at the duties for your position as described on our website and consider any updates or edits that need to be made by the April meeting.
- Continuity files are important to capture lessons learned. An after-action report for each officer is suggested after they depart office and should consist of tips on good things to do and know to help with the transition. The Secretary should keep these on file.
- Financials: We need a budget for the four meetings a year, either standing or annual depending on locations.
- The proposed bylaws were sent out and received very little feedback. The minor changes were mostly grammatical changes and increasing the flexibility on the requirement for four meetings a year. Also, the bylaws should be updated regarding the three incorporators. Currently, there is a name in the bylaws and it would be better and more flexible to change the name to an office instead. This particular issue of the names in the bylaws involves the matured annuity, so it needs to be resolved before changing any of the bylaws.

Action Item:

Consider updates to Chapter Officer and Volunteer duties listed on website.

Past-President's Report

No new developments to report.

Secretary Report

No report at this time.

Treasurer Report

The Treasurer presented a written report which was approved by voice vote. The current balance of the science teacher account is \$3,622.85. The current balance of the student scholarship account is \$4,805.39. The current operating account balance is \$26,105.99.

Committee Vote:

Approved

The Finance committee determined that all of the money, including the science teacher and student scholarship accounts, goes into the operating bank account initially.

Issues:

- Resolution of closing out the Lincoln annuity that has matured.
- PayPal fees are 30¢ plus 2.2% of the transaction value.
- Drawing out “income” from annuities. There is approximately \$2,598 available without penalty and an additional \$3,180 available if we pay penalties. Any monies drawn out will be distributed to the science teacher, student scholarship and operating bank accounts.
- Resolution of additions to or subtractions from the Science Teacher Workshop and the student scholarship bank accounts.

Dues will be raised in 2014 for all memberships. Annual Member dues will be raised to \$20 from the current \$10, Affiliate dues will be raised to \$200 annually from the current \$150; dues will include exhibit space, registration, and lunch at the annual affiliate’s fair. Student dues will be raised to \$10.

Estimated Income: \$9,820
Projected Expenses: \$9,820

Motion to accept Treasurer’s Report John Salsman Warren Snell (second) Motion passes

Will Pate’s ad hoc committee discussed the process for pre-registration and how much the meeting fee is if the person is pre-registered, but does not pay before the last day of pre-registration. They determined that attendees must register and pay at the same time if they want the pre-registration price. If they pre-register and then pay at the door, they will be charged the higher price.

Ad Hoc Committee Report for Reimbursement of Speakers Report

Ad Hoc committee (Amanda Sullivan, Warren Snell and Ed Bailey) does not recommend waiving the registration and lunch fees for non-STC-HPS member speakers.

Ad Hoc committee will develop written policy for EC vote.

Fall 2013 meeting (Sometime in September), Special Topic Meeting: Radiation Sources and Radiography in the Oil and Gas Industry at UTHSC-H (July 1, 2013 for The Billet's deadline). The Billet deadline for articles is two months before the particular meeting to allow for publication one month before the meeting.

Science Teacher Workshop (STW)

Workshop materials in Houston that were previously stored and used by Eva Legler have been retrieved and sorted. Outdated materials were disposed and anything useful for future workshops was kept and added to our current supplies.

All of the CDV instruments that were being stored in Austin have been retrieved (we lost our storage space) and will be transported to Waco on January 18 and added to additional units that are being stored and maintained by Ken Krieger. Many of these instruments have been checked by KI-4-U and should be operational. Ken has also been testing which instruments are operational or not (with the help of TSTC students as one of their lab classes) We have not received any donated instruments from counties or other entities from the discontinued DSHS program. Efforts to get instruments will continue when possible. Because of this transition, we are not able to report our current number of working instruments.

Workshop information was given to a number of interested teachers in September 2012 at the Alamo Regional Academy of Science and Engineering (ARASE) science fair seminar in San Antonio. We have not however, received any calls from this effort.

There have not been any workshops held since the last report nor are there any scheduled in the immediate future.

Karen Blanchard submitted a letter of resignation as this committee's Chair to the Chapter President.
